An underlying mission of Touchstone Farm (TSF) is to make our services available to all participants whose application for registration is accepted. TSF is able to fulfill this mission through the generosity of our supporters, fundraisers and grants. The administration of a financial aid program is based strictly on need. In an effort to help fund as many TSF participants as possible, the Financial Aid Committee will only approve a portion of the total cost of tuition

APPLICATION FOR FINANCIAL AID

When applying to participate in a TSF program, you may request a *Financial Aid Application* and submit it with your application for participation. Financial aid is awarded only after the application has been reviewed and approved for a TSF program by the TSF Financial Aid Committee.

• The deadline for financial aid applications is 30 days prior to the start of the event or workshop!

AWARDING OF FINANCIAL AID

All information provided on the *Financial Aid Application* is kept in strict confidence. The Financial Aid Committee will meet to review your request and then send you written notification within two weeks of reviewing the application. The Financial Aid Committee may find it necessary to request additional information. This is arranged by the TSF Financial Aid Committee and TSF Financial Administrator on a confidential basis.

- Financial aid awards will be based upon both the applicants' need and the amount of funds available for the year. Financial aid is awarded in the form of credit toward the tuition for scheduled services.
- In an effort to provide as many participants as possible with financial aid, TSF will only be funding a portion of the total tuition cost.
- Any lessons missed not the fault of Touchstone Farm will NOT be made up.
