## COVID Guidelines for Summer 2021

Please know that the following information is based upon the NH State guidelines as they are currently published by the Governor's office. These guidelines are continuously updating as new information becomes available, so please note that the information contained within is subject to change at any time based upon revised information published by the Governor's office. We will be sure to communicate any changes with you ASAP!

### Required Pre-arrival Procedure:

Campers and staff **must have an upper respiratory specimen collected within 7 days prior to arrival at camp for SARS-CoV-2 testing with a PCR-based test (or other comparable NAAT test)**. A negative test result must be returned and submitted to us before your camper is permitted to arrive at camp. Low-risk behaviors must be ensured after testing is conducted and must ensue prior to camp arrival.

Please screen your camper for COVID-19 symptoms during the 7 days before arrival.

Has your camper experienced any of the following symptoms in the past 7 days?

- Fever or chills
- Cough
- Shortness of breath or difficulty breathing
- Fatigue
- Muscle or body aches
- Headache
- New loss of taste or smell
- Sore throat
- Congestion or runny nose
- Nausea or vomiting
- Diarrhea

If your camper has had any of the above symptoms, **DO NOT** come to camp.

Your camper will be tested again upon arrival at the Barbara C. Harris Center by a certified medical professional. We will keep you posted if any testing policies change, but as of now every camper will be tested.

Please practice caution, engaging in only minimal to no risk behavior with your camper for at least 7 days before arriving to camp. If your camper is around large groups of people, please ensure that social distancing, mask wearing, and hand sanitizing measures are employed. We must comply with the

Governor's safety guidelines to be able to offer camp, and we are trying to keep camp safe by not risking any unnecessary exposure to our campers and/or staff.

**\*\*While we certainly hope this doesn't happen, if your camper does come into contact with a symptomatic individual, your camper must quarantine for 10 days prior to camp arrival.**

### **Arrival day at Pony Farm (YAY!)**

We will be giving each family an assigned time to arrive at the Barbara C. Harris Center and drop off their camper(s). Please make sure you are arriving at that designated time, no earlier and no later. We are hoping to make this process as smooth as possible. Campers and family members will need to employ social distancing measures and mask wearing during the drop off process. Unfortunately, families will not be able to linger on site once they have finished settling their camper(s) in the cabin.

### **Ongoing Safety Measures during Pony Farm Summer Camp Sessions (YAY!)**

The guidelines published by the Governor's office have defined us (our Pony Farm campers and staff) as our "own pod", meaning that we are characterized similarly to a single family home unit.

Unless your camper(s) choose(s) to employ mask wearing, we will not require that any camper wear masks during regular activities that involve only "our pod". Mask wearing will be employed whenever people outside of "our pod" (including, but not limited to, staff not involved in Pony Farm Summer Camp or regular lesson students) are present and proper social distancing measures cannot be achieved or maintained. Please make sure you are sending your camper with enough clean masks to last the week.

### **COVID Refund Policy**

If your camper(s) test(s) positive prior to arrival at camp or on arrival day, we will work with you to try to find your camper(s) another spot in a session later in the summer after your camper's negative COVID test results are attained and submitted. In cases where this resolution cannot be arranged, refunds will be given only if we can fill your camper's spot from our waiting list.
